CRITERIA
for induction into the
Paper Industry International Hall of Fame, Inc. [PIIHF]

MISSION: To recognize people who have made preeminent contributions to the paper industry* worldwide by inducting them into the Paper Industry International Hall of Fame, Inc.

To display historical elements of the industry and to provide an education center for industry advancement.

**The term "paper industry" includes pulp and paper, board, forest products, converters, allied industries (supplier/buyer), trade associations, and academic/research institutions.*

FREQUENCY: Candidates may be nominated or selected any time during the year, but the formal ceremony honoring the inductees will be held annually, preferably during Fall.

The Board of Directors of PIIHF may determine that no one should be inducted, or that more than one individual should be inducted in a given year.

**INDUCTEE
CATEGORIES:**

PIIHF inductee will be an individual(s), who has pioneered and/or helped the world's paper and allied industries to flourish. Recognition will be based on contributions in these categories: *[alphabetically arranged]*

**NOMINATING
PROCEDURE:**

Nomination for induction into the PIIHF will be made to the Honors Committee of the Board of Directors using the official Nomination Form. **Hard copies are preferred.** You may request a nomination form from our office or print from our website www.paperhall.org

Multiple nominations of any candidate by several groups or individuals are strongly discouraged, since only two sponsors per candidate are needed to assure the nomination's full and careful consideration.

It is not necessary to re-nominate a candidate each year, since the Honors Committee carries forward the names of those nominees not selected. After five years, however, the nomination must be reactivated and brought up to date, or it will be dropped.

Nominations cannot be made by any current members of the Honors Committee or of the PIIHF Board of Directors, since they are responsible for evaluating the nominations.

CAUTION: Penalty for knowingly submitting wrong information for the purpose of gaining election into the PIIHF will be severe. Nomination will be rejected, and/or inductee's name withdrawn, if at any time the Honors Committee learns and determines that the crucial information used in making selection was misleading or false.

SELECTION: The Honors Committee will consider all valid nominations and submit its recommendations to the PIIHF Board of Directors. These recommendations will be reviewed by the PIIHF Board and final selections made at least three months prior to the Award Ceremony. The Board of Directors shall consider only nominees proposed by the Honors Committee.

The Board may, by a vote of two-thirds of the members present at a regular or special meeting, induct a candidate(s) recommended by the Honors Committee into PIIHF. Board's decision will be final.

ANNOUNCEMENT: The selected inductee will be notified as soon as possible after the Board's decision. Public announcement of all inductees will follow.

PRESENTATION: The inductee will be presented with a lasting memento at the induction ceremony. The recipient will publicly acknowledge with appropriate remarks.

If the recipient is unable to attend the presentation ceremony, for some reason of health or other extenuating circumstance, the award may be received and acknowledged by an appropriate representative on the inductee's behalf.

The inductee's plaque, with supporting memorabilia, will be displayed at the ceremony (same or following year) and then permanently housed in the Hall of Fame.
